**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EXECUTION OF A MEMORANDUM OF UNDERSTANDING WITH PROSPERITY SOCIAL COMMUNITY DEVELOPMENT GROUP, INC. TO PROVIDE AN AFTER SCHOOL PROGRAM AT THE NORTH MIAMI PUBLIC LIBRARY; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami Public Library is desirous of providing programming that aims to create a learning space to assist both the family and students; and

**WHEREAS**, the City wishes to partner with Prosperity Social Community Development Group, Inc. to provide an After School Program and Summer Camp; and

**WHEREAS**, the program will provide education support for children ages 5-12, in grades K-5

**WHEREAS**, the Mayor and City Council believe that a Memorandum of Understanding agreement for this purpose will benefit the residents of the City and should be entered into with Prosperity Social Community Development Group, Inc.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.** **Approval.** The Mayor and City Council hereby approve the Memorandum of Understanding with Prosperity Social Community Development Group, Inc.


**Section 2.** **Authority of City Manager.** The City Manager is hereby authorized to execute this Memorandum of Understanding.

**Section 3.** **Effective Date.** This Resolution shall be affective upon adoption.
