

ORDINANCE NO. 1472

**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE CITY MANAGER TO MAKE
ADJUSTMENTS TO THE MINIMUM FUND ALLOCATION
AMOUNT IN THE RESERVE FUND ACCOUNT AS PART
OF THE CITY'S FISCAL YEAR BUDGET PROCESS
PURSUANT TO SECTION 2-2 OF THE CITY CODE;
PROVIDING FOR AN EFFECTIVE DATE AND ALL
OTHER PURPOSES.**

WHEREAS, Section 2-2 of the City of North Miami ("City") Code of Ordinances permits the City Manager to make adjustments to the minimum fund allocation amount in the reserve fund account as part of the City's fiscal year budget process upon adoption of an ordinance by the Mayor and City Council; and

WHEREAS, in accordance with Section 2-2 of the City Code, at least four (4) affirmative votes of the Mayor and City Council shall be required for the approval of an ordinance authorizing the City Manager to make adjustments to the City's reserve account minimum fund allocation; and

WHEREAS, the City Manager has presented to the Fiscal Year 2021-2022 City Budget to the Mayor and City Council and has made a recommendation that adjustments to the minimum fund allocation in the City's reserve account will be necessary as part of this year's fiscal year budget process; and

WHEREAS, the Mayor and City Council of the City of North Miami have determined that it is in the best interest of the City to authorize the City Manager to make any adjustments to the reserve account minimum fund allocations that are necessary as part of the City's fiscal year budget process.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, THAT:**

Section 1. Authority of City Manager. The Mayor and City Council hereby authorize the City Manager to make adjustments to the minimum fund allocation account of the

reserve fund account as part of the City's fiscal year budget process pursuant to Section 2-2 of the City Code.

Section 2. Effective Date. This Ordinance shall become effective immediately upon adoption on second reading.

PASSED AND ADOPTED by a 5-0 vote of the Mayor and City Council of the City of North Miami, Florida, on first reading this 22nd day of September, 2021.
