

RESOLUTION NO. 2021-R-134

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA APPROVING THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY (“NMCRA”) FISCAL YEAR 2021-2022 BUDGET; AUTHORIZING THE CITY MANAGER TO TRANSMIT THE NMCRA FISCAL YEAR 2021-2022 BUDGET TO MIAMI-DADE COUNTY; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTION NECESSARY TO COMPLETE THE APPROVAL PROCESS FOR THE NMCRA FISCAL YEAR 2021-2022 BUDGET WITH MIAMI-DADE COUNTY; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the Interlocal Cooperation Agreement (the “Agreement”) between the North Miami Community Redevelopment Agency (the “NMCRA”), the City of North Miami (the “City”) and Miami-Dade County (the “County”) requires, among other things, the NMCRA to annually adopt and transmit a budget and annual report to the City and County for review and approval by the City Council and Board of County Commissioners (the “BCC”), respectively; and

WHEREAS, the Agreement also requires that the annual budget for the NMCRA be adopted by the NMCRA and the City prior to review and approval by the BCC; and

WHEREAS, the Fiscal Year 2021-2022 Budget for the NMCRA is attached hereto as Exhibit “A” (the “NMCRA Fiscal Year 2021-2022 Budget”); and

WHEREAS, all the expenses included in the NMCRA Fiscal Year 2021-2022 Budget are in accordance with state law, interlocal agreements including the Agreement and the NMCRA Redevelopment Plan; and

WHEREAS, the NMCRA previously approved the NMCRA Fiscal Year 2021-2022 Budget; and

WHEREAS, the Mayor and City Council desire to approve the NMCRA Fiscal Year 2021-2022 Budget.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Recitals. The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.

Section 2. Budget Approval. The NMCRA Fiscal Year 2021-2022 Budget attached hereto as Exhibit "A" is hereby approved and adopted.

Section 3. Transmittal. The City Manager is hereby authorized to transmit the NMCRA Fiscal Year 2021-2022 Budget to the County for review and approval.


Section 4. Authority of City Manager. The City Manager is hereby authorized to take all action necessary to complete the approval process for the NMCRA Fiscal Year 2021-2022 Budget with the County.

Section 5. Effective Date. This Resolution shall take effect immediately upon approval.
