

RESOLUTION NO. 2021-R-142

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND KIMLEY-HORN AND ASSOCIATES, INC., FOR CONSTRUCTION PHASE ENGINEERING SERVICES FOR THREE (3) WATER MAIN IMPROVEMENT PROJECTS, AT A COST NOT TO EXCEED ONE HUNDRED EIGHTY-FOUR THOUSAND THREE HUNDRED FOURTEEN DOLLARS (\$184,314.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.

WHEREAS, on December 7, 2017, the City advertised *Request for Qualifications #08-17-18, Continuing Professional Architectural & Engineering Services* (“RFQ”), for the purpose of retaining a pool of experienced, licensed and insured architectural and engineering firms to provide on a continuing as-needed, when needed basis, the following specific services: Architecture, Landscape Architecture, Civil Engineering, Planning and Urban Design, Roadway, Traffic and Transportation Engineering and Consulting, Water/Waste Water Engineering, Water Resources and Stormwater Design and Environmental Engineering (“Services”); and

WHEREAS, the RFQ was undertaken in accordance with Florida’s Consultants’ Competitive Negotiation Act, under Section 287.055, Florida Statutes; and

WHEREAS, in response to the RFQ, Kimley Horn & Associates, Inc. (“Consultant”) submitted its qualifications for the provision of professional engineering services and was approved to be included on the City’s list of pre-qualified firms pursuant to Resolution No. 2019-R-15; and

WHEREAS, the proposed agreement encompasses Engineering Services to assist the City during the construction phase of the water improvement projects at the following locations: N.E. 6 Avenue from 131 Street to 137 Street, N.E. 118 Street from Biscayne Canal Road to W. Dixie Highway, and N.W. 7 Avenue from N.W. 137 Avenue to N.W. 141 Street; and

WHEREAS, the services will include: progress meetings, a resident project representative, shop drawing review, contract clarification, review of pay application, and project close-out for

total fee not to exceed One Hundred Eighty-Four Thousand Three Hundred Fourteen Dollars (\$184,314.00); and

WHEREAS, the City Administration respectfully requests that the Mayor and City Council authorize the City Manager and City Attorney to negotiate and execute an agreement with the Consultant for the provision of Services, relating to the water main improvement projects.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement between the City of North Miami and Kimley Horn & Associates, Inc., for construction phase engineering services for three (3) water main improvement projects, at a cost not to exceed One Hundred Eighty-Four Thousand Three Hundred Fourteen Dollars (\$184,314.00).

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
