

**RESOLUTION NO. 2021-R-140**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF BLDM USA, LLC, AS THE LOWEST-RESPONSIVE AND RESPONSIBLE BIDDER TO PROVIDE ALL LABOR, EQUIPMENT, MATERIALS, SERVICES AND EXPERTISE REQUIRED TO COMPLETE THE REHABILITATION OF WASTEWATER PUMP STATION "A", IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 55-20-21; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH BLDM USA, LLC, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED ONE MILLION TWO HUNDRED FORTY-ONE THOUSAND SIXTY-NINE DOLLARS (\$1,241,069.00); PROVIDING FOR AN EFFECTIVE DATE AND FOR ALL OTHER PURPOSES.**

**WHEREAS**, on July 7, 2021, the City of North Miami ("City") advertised *Invitation for Bid No. 55-20-21 – Rehabilitation of Pump Station No. "A"* ("IFB"), as amended, seeking competitive bids from qualified, licensed and insured contractors to provide all labor, equipment, materials, services and expertise required to complete the rehabilitation of Wastewater Pump Station "A" (collectively referred to herein as "Services"), in accordance with the terms, conditions, and specifications contained in the IFB; and

**WHEREAS**, a total of two (2) bids were received in response to the IFB, from which BLDM USA, LLC ("Contractor") was found by City administration to meet the experience and qualification requirement under the IFB, and was therefore ranked as the lowest-responsive and responsible bidder for the provision of Services

**WHEREAS**, Contractor has manifested the capability and willingness of completing Services within three hundred sixty (360) days from the City's issuance of a Notice to Proceed, at a cost not to exceed One Million One Hundred Forty-One Thousand Sixty-Nine Dollars (\$1,141,069.00); and a contingency of One hundred Thousand Dollars (\$100,000.00) for unforeseen conditions or for City requested changes.

**WHEREAS**, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor, and authorize the City Manager and City Attorney to negotiate and execute an agreement for Services; and

**WHEREAS**, the Mayor and City Council find the selection of Contractor to be in the best interest of the City, and that the expeditious provision of Services are designed to protect the health, safety, and welfare of City residents.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Approving Selection of Contractor.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of BLDM USA, LLC, as the lowest-responsive and responsible bidder to provide all labor, equipment, materials, services and expertise required to complete the rehabilitation of Wastewater Pump Station No. "A", in accordance with the terms, conditions and specifications contained in the *Invitation for Bid No. 55-20-21 – Rehabilitation of Pump Station "A"*.

**Section 2. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with BLDM USA, LLC, for the provision of services in the amount not to exceed One Million One Hundred Forty-One Thousand Sixty-Nine Dollars (\$1,141,069.00) and a contingency of One Hundred Thousand Dollars (\$100,000.00) for unforeseen conditions or for City requested changes.

**Section 3. Effective Date.** This Resolution shall become effective upon adoption.
