

**RESOLUTION NO. 2021-R-146**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING  
THE SUBMITTAL OF A GRANT APPLICATION AND  
AUTHORIZING THE CITY MANAGER AND CITY  
ATTORNEY TO NEGOTIATE AND EXECUTE AN  
AGREEMENT BETWEEN THE CITY OF NORTH MIAMI  
AND THE MLB-MLBPA YOUTH DEVELOPMENT  
FOUNDATION, TO SECURE GRANT FUNDS; PROVIDING  
FOR AN EFFECTIVE DATE, AND FOR ALL OTHER  
PURPOSES.**

**WHEREAS**, the Mayor and City Council are desirous of securing a grant from the Major League Baseball - Major League Baseball Players Association (“MLB-MLBPA”) Youth Development Foundation and the (“Foundation”); and

**WHEREAS**, the City of North Miami (“City”) is requesting a grant in the amount of Thirty-Five Thousand Dollars and No Cents (\$35,000.00) with no required match for a total project cost in the amount of Thirty-Five Thousand Dollars and No Cents (\$35,000.00) ; and

**WHEREAS**, funds will be used to increase participation in and expand access to youth baseball and softball through the renovation of fields and practice facilities and installation of new lighting; and

**WHEREAS**, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the Foundation.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

**Section 1. Ratification of Submittal of Application.** The Mayor and City Council hereby ratify the submittal of the City of North Miami’s application for a grant from the MLB-MLBPA Youth Development Foundation to secure grant funds.

**Section 2. Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of

North Miami, Florida and the MLB-MLBPA Youth Development Foundation to obtain grant funds.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
