

RESOLUTION NO. 2021-R-160

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND CES CONSULTANTS, INC., FOR CONSTRUCTION PHASE SERVICES FOR TWO (3) FORCE MAIN IMPROVEMENT PROJECTS, ALONG NORTHWEST 12TH AVENUE AT A COST NOT TO EXCEED TWO HUNDRED TWENTY THOUSAND SIX HUNDRED AND NINETEEN DOLLARS (\$220,619.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on December 7, 2017, the City advertised *Request for Qualifications #08-17-18, Continuing Professional Architectural & Engineering Services* (“RFQ”), for the purpose of retaining a pool of experienced, licensed and insured architectural and engineering firms to provide on a continuing as-needed, when needed basis, the following specific services: Architecture, Landscape Architecture, Civil Engineering, Planning and Urban Design, Roadway, Traffic and Transportation Engineering and Consulting, Water/Waste Water Engineering, Water Resources and Stormwater Design and Environmental Engineering (“Services”); and

WHEREAS, the RFQ was undertaken in accordance with Florida’s Consultants’ Competitive Negotiation Act, under Section 287.055, Florida Statutes; and

WHEREAS, in response to the RFQ, CES Consultants, Inc. (“Contractor”) submitted its qualifications for the provision of professional engineering services and was approved to be included on the City’s list of pre-qualified firms pursuant to Resolution No. 2019-R-15; and

WHEREAS, the proposed project encompasses Construction Phase Services to assist the City during the construction phase of the force main improvement projects along Northwest 12th Avenue; and

WHEREAS, the services will be performed for total fee not to exceed Two Hundred Twenty Thousand Six Hundred and Nineteen Dollars (\$220,619.00); and

WHEREAS, the City administration respectfully requests that the Mayor and City Council authorize the City manager and City Attorney to negotiate and execute an agreement with Contractor for the provision of Services, relating to the force main improvement projects.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement between the City of North Miami and CES Consultants, Inc., for contract phase services for two (2) force main improvement projects, at a cost not to exceed Two Hundred Twenty Thousand Six Hundred and Nineteen Dollars (\$220,619.00).

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
