

RESOLUTION NO. 2021-R-157

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING
THE SUBMITTAL OF A GRANT APPLICATION AND
AUTHORIZING THE CITY MANAGER AND THE CITY
ATTORNEY TO NEGOTIATE AND EXECUTE AN
AGREEMENT BETWEEN THE CITY OF NORTH MIAMI
AND UNITED STATES CONFERENCE OF MAYORS;
PROVIDING FOR AN EFFECTIVE DATE AND ALL
OTHER PURPOSES.**

WHEREAS, the Mayor and City Council are desirous of ratifying a resolution authorizing the City of North Miami to obtain grant funding in the amount of One Hundred Twenty-Five Thousand Dollars (\$125,000.00) from the Childhood Obesity Prevention/Environmental Health and Sustainability Awards sponsored by the United States Conference of Mayors; and

WHEREAS, Childhood Obesity Prevention/Environmental Health and Sustainability Awards is an initiative developed by Mayors throughout the United States to help end Childhood Obesity Prevention and Health; and

WHEREAS, the Mayor and City Council wish to authorize the submittal of a grant application, as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City of North Miami and the United States Conference of Mayors.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

Section 1. Ratification of Submittal of Application. The Mayor and City Council hereby ratify the submittal of the City of North Miami's Application for a Child Obesity Prevention, Environmental/Health and Sustainability Awards Grant.

Section 2. Authority to City Manager and City Attorney. The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the United States Conference of Mayors to obtain a grant from the Child Obesity Prevention, Environmental/Health and Sustainability Awards.

Section 3. Effective Date. This Resolution will be effective immediately upon adoption.
