

RESOLUTION NO. 2021-R-178

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND AMBRO, INC., FOR TRAFFIC CALMING IMPROVEMENT AND CONSTRUCTION PHASE ENGINEERING SERVICES FOR THE INTERSECTION LOCATED AT NW 120 STREET AND NW 16 AVENUE, AT A COST NOT TO EXCEED FIFTY-FIVE THOUSAND EIGHT HUNDRED TEN DOLLARS (\$55,810.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on December 7, 2017, the City advertised *Request for Qualifications #08-17-18, Continuing Professional Architectural & Engineering Services* (“RFQ”), for the purpose of retaining a pool of experienced, licensed and insured architectural and engineering firms to provide on a continuing as-needed, when needed basis, the following specific services: Architecture, Landscape Architecture, Civil Engineering, Planning and Urban Design, Roadway, Traffic and Transportation Engineering and Consulting, Water/Waste Water Engineering, Water Resources and Stormwater Design and Environmental Engineering (“Services”); and

WHEREAS, the RFQ was undertaken in accordance with the Florida’s Consultants’ Competitive Negotiation Act, under Section 287.055, Florida Statutes; and

WHEREAS, in response to the RFQ, Ambro, Inc. (“Consultant”) submitted its qualifications for the provision of Transportation/Traffic Engineering & Consulting services and was approved to be included on the City’s list of pre-qualified firms pursuant to Resolution No. 2019-R-15; and

WHEREAS, the proposed traffic circle project requires services consisting of performing roadway design improvements to add a traffic circle at the intersection of NW 120th Street and NW 16th Avenue; and

WHEREAS, services will include: Pre-Design Development Phase, Preliminary Design Development Phase, Final Plans Development (Construction Drawings), Meetings, and Construction Phase Services for total fee not to exceed Fifty-Five Thousand Eight Hundred Ten Dollars (\$55,810.00); and

WHEREAS, the City administration respectfully requests that the Mayor and City Council authorize the City manager and City Attorney to negotiate and execute an agreement with Consultant for the provision of Services, relating to the traffic circle installation project.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement between the City of North Miami and Ambro, Inc., for traffic calming improvement and construction phase engineering services for the intersection located at NW 120 Street and NW 16 Avenue, at a cost not to exceed Fifty-Five Thousand Eight Hundred Ten Dollars (\$55,810.00).

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
