

RESOLUTION NO. 2021-R-176

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND SGM ENGINEERING, INC., FOR 40-YEAR RECERTIFICATION SERVICES FOR THREE (3) CITY FACILITIES, AT A COST NOT TO EXCEED TWENTY-EIGHT THOUSAND FIFTY DOLLARS (\$28,050.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on December 7, 2017, the City of North Miami (“City”) advertised *Request for Qualifications #08-17-18, Continuing Professional Architectural & Engineering Services* (“RFQ”), for the purpose of retaining a pool of experienced, licensed and insured architectural and engineering firms to provide on a continuing as-needed, when needed basis, the following specific services: Architecture, Landscape Architecture, Civil Engineering, Planning and Urban Design, Roadway, Traffic and Transportation Engineering and Consulting, Water/Waste Water Engineering, Water Resources and Stormwater Design and Environmental Engineering (“Services”); and

WHEREAS, the RFQ was undertaken in accordance with the Florida’s Consultants’ Competitive Negotiation Act, under Section 287.055, Florida Statutes; and

WHEREAS, in response to the RFQ, SGM Engineering, Inc. (“Consultant”) submitted its qualifications for the provision of engineering services and was approved to be included on the City’s list of pre-qualified firms pursuant to Resolution No. 2019-R-15; and

WHEREAS, the City’s Building Department has advised that three (3) City facilities are due for structural and electrical safety inspections for the 40-year Recertification, pursuant to Section 5-37 of the City’s Code of Ordinances; and

WHEREAS, the City’s Public Works Department requested a proposal for structural and electrical safety inspection services for City Hall, Library, and CP&D facilities; and

WHEREAS, services provided by Consultant will include: review of the available building record drawings, perform inspections of the buildings, determine the condition of the buildings general structure, provide a report in conformity with Miami-Dade County Procedural Guidelines for building recertification for each facility, provide a report of the building structural,

electrical and parking lot illumination condition for total fee not to exceed Twenty-Eight Thousand Fifty Dollars (\$28,050.00); and

WHEREAS, the City administration respectfully requests that the Mayor and City Council authorize the City Manager and City Attorney to negotiate and execute an agreement with Consultant for the provision of Services, relating to the 40-Year Re-certification of city facilities.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement between the City of North Miami and SGM Engineering, Inc., for 40-Year Re-certification services for three (3) City facilities, at a cost not to exceed Twenty-Eight Thousand Fifty Dollars (\$28,050.00).

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
