

RESOLUTION NO. 2021-R-164

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPOINTING MARK W. BOBB TO THE NORTH MIAMI UNIVERSITY RELATIONS BOARD, IN ACCORDANCE WITH RESOLUTION R-2000-13; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the University Relations Board, established by Resolution R-2000-13 on February 8, 2000, coordinates activities and explores mutual concerns with institutions of higher learning; and

WHEREAS, the Board, previously known as Town and Gown Committee, recommends programs and projects to the City Council that coordinate relations between the City and local institutions of higher learning.

WHEREAS, pursuant to Resolution No. R-2000-13, the Board shall consist of five (5) members appointed at-large by the Mayor and City Council; and

WHEREAS, appointees shall reside in the City of North Miami or be affiliated with a business located in North Miami; and

WHEREAS, Councilwoman Cassandra Timothe desires to appoint Mark W. Bobb to the North Miami University Relations Board.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida and are incorporated herein.


Section 2. **Appointments.** The Mayor and City Council of the City of North Miami, Florida, hereby appoints Mark W. Bobb to the North Miami University Relations Board.

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
