The Meeting will be broadcast live for members of the public on livestream, NoMi TV (Comcast: Channel 77, U-verse: Channel 99), YouTube and Champs. The purpose of the Regular Council Meeting is to discuss, approve or disapprove items concerning operations in the City of North Miami. Interested members of the public are invited to attend and participate.

Members of the public are invited to attend the Council Meeting and provide oral or written comments on the matter. Any person, not appearing in person, interested in making comments or posing questions on matters of public concern or on any item on the agenda may do so prior to the meeting taking place by email to publiccomment@northmiamifl.gov. Comments must be received by 10 a.m. the day of the Council Meeting in order to be read into the record during the hearing. Email comments and questions shall not exceed three (3) minutes when read. Comments received after the deadline will become part of the record, but will not be read during the hearing.

- IN ACCORDANCE WITH THE PROVISIONS OF SECTION 286.0105, FLORIDA STATUTES, ANYONE WISHING TO APPEAL ANY DECISION MADE BY THE CITY OF NORTH MIAMI CITY COUNCIL, WITH RESPECT TO ANY MATTER CONSIDERED AT SUCH MEETING OR HEARING, WILL NEED A RECORD OF THE PROCEEDINGS AND, FOR SUCH PURPOSE, MAY NEED TO ENSURE THAT A VERBATIM RECORD OF THE PROCEEDINGS IS MADE, INCLUDING THE TESTIMONY AND EVIDENCE UPON WHICH THE APPEAL IS TO BE BASED.
