

RESOLUTION NO. 2022-R-02

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF MARCDAN, INC., AS THE LOWEST RESPONSIVE-RESPONSIBLE CONTRACTOR TO FURNISH LABOR, EQUIPMENT, MATERIALS, AND EXPERTISE REQUIRED TO PERFORM THE EIGHTEEN (18) INCH FORCE MAIN REPLACEMENT PROJECT ALONG N.E. 135 STREET; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED CONTRACTOR, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED ONE MILLION EIGHT HUNDRED SIXTY-SEVEN THOUSAND FOUR HUNDRED NINETY-SEVEN DOLLARS (\$1,867,497.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 59-20-21; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on September 16, 2021, the City of North Miami ("City") advertised *Invitation for Bids No. 59-20-21 – 18-Inch Force Main replacement along N.E 135th Street* ("IFB"), requesting bids from qualified and experienced contractors to furnish all labor, equipment, materials and expertise needed for the successful replacement of an eighteen (18) inch force main along N.E. 135 Street, in accordance with the specifications and conditions contained in the IFB (collectively referred hereto as "Services"); and

WHEREAS, in response to the IFB, Marcdn, Inc. ("Contractor") submitted its bid and was competitively selected by City administration as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City , in accordance with the terms, conditions and specifications contained in the IFB, at a cost not to exceed One Million Seven Hundred Fifty-Two Thousand Four Hundred Ninety-Seven Dollars (\$1,752,497.00), plus an additional project contingency amount of One Hundred Fifteen Thousand Dollars (\$115,000.00) to cover the cost of any unforeseen conditions or City requested changes, for a total cost of One Million Eight Hundred Sixty-Seven Thousand Four Hundred Ninety-Seven Dollars (\$1,867,497.00); and

WHEREAS, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor and further authorize an agreement for the completion of Services; and

WHEREAS, the Mayor and City Council find the selection of Contractor to be in the best interest of the City, and that the provision of Services are designed to protect the public health, safety, and welfare.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Selection Approval. The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of Marcdn, Inc., as the lowest responsive-responsible contractor to perform the Eighteen (18) Inch Force Main Replacement Project along N.E. 135 Street.

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the stated services, in the amount not to exceed One Million Eight Hundred Sixty-Seven Thousand Four Hundred Ninety-Seven Dollars (\$1,867,497.00), in accordance with the terms, conditions and specifications contained in *Invitation for Bids No. 59-20-21 – 18-Inch Force Main replacement along N.E 135th Street*.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
