

RESOLUTION NO. 2022-R-07

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EXECUTION OF AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE STATE OF FLORIDA, OFFICE OF THE STATE ATTORNEY FOR THE ELEVENTH JUDICIAL CIRCUIT OF FLORIDA TO REIMBURSE THE STATE FOR THE COST OF STATE ATTORNEY PROSECUTION OF CERTAIN CRIMINAL VIOLATIONS OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, section 27.02 of the Florida Statutes, authorizes the State of Florida, Office of the State Attorney for the Eleventh Judicial Circuit of Florida (the “State Attorney”) to enter into the attached agreement with the City of North Miami (“City”) to recover the costs of services associated with the prosecution of municipal ordinance violations of the City of North Miami Code of Ordinances; and

**WHEREAS**, the City desires to enter into an agreement with the State Attorney for the purpose of reimbursing the State Attorney for the cost of the State Attorney prosecuting municipal ordinance violations of the City of North Miami Code of Ordinances, as set for the in Exhibit “A” attached hereto (the “Agreement”); and

**WHEREAS**, the Mayor and City Council finds that it is necessary to reimburse costs to the State Attorney associated with the enforcement and prosecution of violations of the City of North Miami Code of Ordinances in order to maintain and improve the health, safety and welfare of this community.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Approval of Agreement.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the Agreement for reimbursement of costs for prosecution of municipal ordinance violations attached hereto as “Exhibit A.”

**Section 2.      Authority of City Manager.** The City Manager is hereby authorized to execute the Agreement with the Miami-Dade State Attorney’s Office.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
