

RESOLUTION NO. 2022-R-08

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF ACRE ENGINEERING AND CONSTRUCTION, INC., AS THE LOWEST RESPONSIVE-RESPONSIBLE CONTRACTOR TO FURNISH LABOR, EQUIPMENT, MATERIALS, AND EXPERTISE REQUIRED TO PERFORM THE FORCE MAIN REPLACEMENT PROJECT ALONG N.W. 12 AVENUE FROM N.W. 95 STREET TO N.W. 125 STREET; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED CONTRACTOR, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED TWO MILLION THREE HUNDRED TWENTY THOUSAND DOLLARS (\$2,320,000.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 58-20-21; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on September 29, 2021, the City of North Miami ("City") advertised *Invitation for Bids ("IFB") No. 58-20-21 – Furnish and Install 8-Inch, 10-Inch, 12-Inch DIP Force Main along NW 12th Avenue from NW 95th Street to NW 125th Street* ("IFB"), requesting bids from qualified and experienced contractors to furnish all labor, equipment, materials and expertise needed for the successful replacement of an 8-inch, 10-inch, 12-inch DIP Force Main in NW 12th Avenue from NW 95th Street to NW 125th Street, in accordance with the specifications and conditions contained in the IFB (collectively referred hereto as "Services"); and

WHEREAS, in response to the IFB, Acre Engineering and Construction, Inc. ("Contractor") submitted its bid and was competitively selected by City administration as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City, in accordance with the terms, conditions and specifications contained in the IFB, at a cost not to exceed Two Million Two Hundred Seventy Thousand Dollars (\$2,270,000.00), plus an additional project contingency amount of Fifty Thousand Dollars (\$50,000.00) to cover

the cost of any unforeseen conditions or City requested changes, for a total cost of Two Million Three Hundred Twenty Thousand Dollars (\$2,320,000.00); and

WHEREAS, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor and further authorize an agreement for the completion of Services; and

WHEREAS, the Mayor and City Council find the selection of Contractor to be in the best interest of the City, and that the provision of Services are designed to protect the public health, safety, and welfare.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of Acre Engineering and Construction, Inc., as the lowest responsive-responsible contractor to perform the Force Main Replacement Project along N.W. 12th Avenue from 95th Street to 125th Street.

Section 2. **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the stated services, in the amount not to exceed Two Million Three Hundred Twenty Thousand Dollars (\$2,320,000.00), in accordance with the terms, conditions and specifications contained in *Invitation for Bids ("IFB") No. 58-20-21 – Furnish and Install 8-Inch, 10-Inch, 12-Inch DIP Force Main along NW 12th Avenue from NW 95th Street to NW 125th Street.*

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
