

RESOLUTION NO. 2022-R-13

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE CITY ADMINISTRATION'S COMPETITIVE SELECTION OF ACOSTA TRACTORS, INC., AS THE LOWEST RESPONSIVE-RESPONSIBLE CONTRACTOR TO FURNISH LABOR, EQUIPMENT, MATERIALS, AND EXPERTISE REQUIRED TO INSTALL A NEW 12-INCH WATER MAIN ON N.E. 6 AVENUE AND N.E. 137 STREET; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE SELECTED CONTRACTOR, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED ONE MILLION ONE HUNDRED NINETEEN THOUSAND SEVEN HUNDRED FOURTEEN DOLLARS AND FIFTY-FIVE CENTS (\$1,119,714.55), IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 06-21-22; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on November 10, 2021, the City of North Miami ("City") advertised *Invitation for Bids No. 06-21-22 – Water Main Projects on N.E 6th Avenue and N.E 137th Street* ("IFB"), requesting bids from qualified, licensed and experienced contractors to provide all the necessary labor, materials, equipment and expertise needed to furnish and install a new 12-inch water main on N.E 6th Avenue and N.E 137th Street, in accordance with the specifications and conditions contained in the IFB (collectively referred hereto as "Services"); and

**WHEREAS**, in response to the IFB, Acosta Tractors, Inc. ("Contractor") submitted its bid and was competitively selected by City administration, as well as the City's engineering firm, as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

**WHEREAS**, the Contractor has manifested the capability and willingness of providing Services to the City, in accordance with the terms, conditions and specifications contained in the IFB, at a cost not to exceed One Million Seventeen Thousand Nine Hundred Twenty-Two Dollars and Thirty-Two Cents (\$1,017,922.32), plus an additional project contingency amount of One Hundred One Thousand Seven Hundred Ninety-Two Dollars and Twenty-Three Cents (\$101,792.23) to cover the cost of any unforeseen conditions or City requested changes, for a total

cost of One Million One Hundred Nineteen Thousand Seven Hundred Fourteen Dollars and Fifty-Five Cents (\$1,119,714.55); and

**WHEREAS**, City administration respectfully requests that the Mayor and City Council approve the selection of Contractor and further authorize an agreement for the completion of Services; and

**WHEREAS**, the Mayor and City Council find the selection of Contractor to be in the best interest of the City, and that the provision of Services are designed to protect the public health, safety, and welfare.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**      **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City Administration's competitive selection of Acosta Tractors, Inc., as the lowest responsive-responsible contractor to perform the installation of a new 12-inch Water Main Project on N.E. 6<sup>th</sup> Avenue and N.E. 137<sup>th</sup> Street.

**Section 2.**      **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the stated services, in the amount not to exceed One Million One Hundred Nineteen Thousand Seven Hundred Fourteen Dollars and Fifty-Five Cents (\$1,119,714.55), in accordance with the terms, conditions and specifications contained in *Invitation for Bids No. 06-21-22 – Water Main Improvements on N.E 6th Avenue and N.E 137th Street.*

**Section 3.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
