**THIS TERMINATION OF MEMORANDUM OF BUSINESS ASSISTANCE
PROGRAM GRANT AGREEMENT** (the “Termination”) is made as of the ____ day of
October, 2021, by the **NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY**, a
public body corporate and politic (the “CRA”) having an address at 735 NE 125 Street, Suite 100,
North Miami, Florida 33161.

R E C I T A L S

1. The CRA and 20 NORTHEAST, LLC, a Florida limited liability company (the
“Grantee”) entered into to that certain Memorandum of Business Assistance Grant Agreement
dated February 17, 2016 (the “Memorandum”), and recorded August 19, 2016, in Official Records
Book 30198, Pages 4312-4315, of the Public Records of Miami-Dade County, Florida relative to
that certain Business Assistance Program Grant Agreement dated February 17, 2016 (the “Grant
Agreement”) pursuant to which the CRA provided a Grant to the Grantee for the rehabilitation of
the real property as more particularly described on Exhibit “A” attached hereto.

2. The CRA desires to terminate the Memorandum and to place all persons upon
notice of such termination.


NOW, THEREFORE, for in consideration of the sum of Ten and No/Dollars (\$10.00)




EXHIBIT "A"

Lots 1, 2, 3, 12 and the Northerly 15 feet of Lot 4, in Block 32 of IRONS MANOR, SECOND ADDITION, according to the Plat thereof, as recorded in Plat Book 17, Page 39, of the Public Records of Miami-Dade County, Florida, with the said Northerly 15 feet of Lot 4 also being described as: Beginning at a point on the Westerly boundary line of West Dixie Highway, and the Southeasterly corner of Lot 3, and the dividing line between Lots 3 and 4, run thence on the dividing line between Lots 3 and 4, in a Northwesterly direction a distance of 105 feet to a point, being the most Westerly point of said Lot 3, run thence Southwesterly parallel with said West Dixie Highway for a distance of 15 feet, run thence Southeasterly parallel to said dividing line of said Lots 3 and 4 to the right of West Dixie Highway, thence Northeasterly on the Westerly right-of-way line of West Dixie Highway to Point of Beginning.
