CORRECTED PURCHASE MORTGAGE AND PROMISSORY NOTE

KNOW ALL MEN BY THESE PRESENTS, and on this 28th day of September: That the CITY OF NORTH MIAMI, a Florida municipal corporation, the owner and holder of a Promissory Note evidencing the debt secured by a certain Residential Construction Mitigation Program (RCMP Mortgage and Note) executed by **DIEULIFAIT GELIN and REINE HENRI** (Mortgagor) to the **CITY OF NORTH MIAMI**, and certain promises and obligations set forth in the Mortgage, upon the following described land situated in Miami-Dade County, Florida:
