

RESOLUTION NO. 2022-R-40

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO PORT CONSOLIDATED, INC. FOR THE PURCHASE AND DELIVERY OF UNLEADED GASOLINE AND DIESEL FUEL FOR CITY OWNED VEHICLES, IN AN AMOUNT NOT TO EXCEED NINE HUNDRED THOUSAND DOLLARS (\$900,000.00) PER YEAR, UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SECTION 7-169 OF THE CITY CODE, ON A CONTRACT AWARDED THROUGH THE SOUTHEAST FLORIDA GOVERNMENTAL PURCHASING COOPERATIVE GROUP - RFP NUMBER E-03-22, IN ORDER TO MAINTAIN A CONTINUOUS SUPPLY AND DELIVERY OF MOTOR FUEL AS REQUIRED FOR CITY OPERATIONS; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on October 28, 2021, the City of Pompano Beach, Florida (“Pompano Beach”), issued *RFP No. E-03-22 – Unleaded Gasoline & Diesel Fuel for Southeast Florida Governmental Purchasing Cooperative Group*. (“RFP”), on behalf of the Southeast Florida Governmental Purchasing Cooperative (“Purchasing Co-op”), requesting competitive sealed proposals from qualified contractors to furnish unleaded gasoline and diesel fuel as a necessary commodity for all government entities participating in the Purchasing Co-op, and in accordance with the terms, conditions, requirement and specifications contained in the RFP (“Fuel Products”); and

**WHEREAS**, in response to the RFP, Port Consolidated, Inc. (“Contractor”), submitted its proposal and was competitively selected by Pompano Beach as the highest ranked proposer, having established the terms and conditions required in the RFP; and

**WHEREAS**, on February 22, 2022, Pompano Beach approved an award to Contractor to provide unleaded gasoline and diesel fuel to thirty-nine (39) participating agencies with an initial five (5) year term, with one (1) option to renew for a five (5) year term; and

**WHEREAS**, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

**WHEREAS**, the City is a current member of the Purchasing Co-op, and thereby entitled to obtain Fuel Products from Contractor at the same favorable rates made available to Pompano Beach under the contract; and

**WHEREAS**, the City administration desires to secure vital deliveries of Fuel Products at a competitive price, utilizing the cooperative purchasing provisions contained in section 7-169 of the City Code, in order to continue the provision of essential City services without interruptions; and

**WHEREAS**, the City Manager determined that it is in the best interest of the City to take advantage of the cooperative pricing for the provision of Fuel Products, at a cost not to exceed Nine Hundred Thousand Dollars (\$900,000.00) per year; and

**WHEREAS**, the Mayor and City Council, have determined that obtaining an uninterrupted supply of Fuel Products at a competitive price, is in the City's best interest.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**     **Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue Purchase Orders to Port Consolidated, Inc. for the purchase and delivery of Unleaded Gasoline and Diesel Fuel for City owned vehicles from Port Consolidated, Inc., in an amount not to exceed Nine Hundred Thousand Dollars (\$900,000.00) per year, in accordance with the Southeast Florida Governmental Purchasing Cooperative Group - RFP No. E-03-22, in order to maintain a continuous supply and delivery of motor fuel as required for City operations.

**Section 2.**     **Effective Date.**         This Resolution shall be effective upon adoption.


