

RESOLUTION NO. 2022-R-39

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE EXECUTION OF AN OFF-SYSTEM
CONSTRUCTION AND MAINTENANCE AGREEMENT
BETWEEN THE CITY OF NORTH MIAMI AND THE
FLORIDA DEPARTMENT OF TRANSPORTATION,
DESIGNATING AND SETTING FORTH THE
RESPONSIBILITIES OF EACH PARTY WITH REGARDS
TO THE MAINTENANCE OF ROADWAY
IMPROVEMENTS ON NW 6th COURT AT THE I-95 EXIT
RAMP LOCATED AT STATE ROAD 916 (NE 135TH
STREET); PROVIDING FOR AN EFFECTIVE DATE AND
ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) is the owner the following road which is not on the State Highway System: NW 6th Court at the I-95 Exit located on State Road 916 (NW 135th Street/Opa-Locka Blvd.); and

WHEREAS, Florida Department of Transportation (“FDOT”) will be undertaking Project Number FPID# 446947-1-52-01 to implement Wrong-Way Driving (WWD) Countermeasures at various locations throughout Miami-Dade County, (the “Project”); a portion of which includes work on the following road not on the State Highway System: NW 6th Court; and

WHEREAS, the Project includes improvements on NW 6th Court, extending from the I-95 southbound off-ramp at SR 916/Opa-Locka Blvd to 150 feet to the north which include milling and resurfacing, and installation of signage and pavement markings; and

WHEREAS, pursuant to the terms of the Agreement, the City will be responsible for reviewing the Project Design Plans and submitting its comments and will shall assume all maintenance responsibilities of the local roadways once the Project is completed; and

WHEREAS, the Mayor and City Council find that entering into an Off-System Construction and Maintenance Agreement, in substantially the attached form, for the maintenance and preservation of the roadway improvements, is in the best interest of the City and should be entered into.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

Section 1. Authorization. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the execution of an Off-System Construction and Maintenance Agreement between the City of North Miami and Florida Department of Transportation, designating and setting forth the responsibilities of each party with regards to the maintenance of roadway improvements on NW 6th Court at the I-95 Exit Ramp located on State Road 916 (NW 135th Street).

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
