

RESOLUTION NO. 2022-R-71

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF BASILE USA, LLC, AS THE LOWEST, RESPONSIVE AND RESPONSIBLE CONTRACTOR TO PERFORM THE WATER MAIN PROJECT ON N.E. 118 STREET FROM BISCAYNE CANAL ROAD TO WEST DIXIE HIGHWAY, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 13-21-22; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH BASILE USA, LLC, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED SEVEN HUNDRED SIXTY-SIX THOUSAND FIVE HUNDRED THREE DOLLARS (\$766,503.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on February 23, 2022, the City of North Miami (“City”) advertised *Invitation for Bid No. 13-21-22 – Water Main Project on N.E. 118th Street from Biscayne Canal Road to West Dixie Highway* (“IFB”), soliciting bids from qualified, licensed, and experienced contractors to provide all the necessary labor, materials, equipment and expertise needed to furnish and install an new eight inch (“8”) water main along N.E. 118th Street from Biscayne Canal Road to West Dixie Highway, in accordance with the specifications and conditions contained in the IFB (collectively referred hereto as “Services”); and

WHEREAS, in response to the IFB, Basile USA, LLC (“Contractor”) submitted its bid and was competitively selected by City administration, as well as the City’s engineering firm, as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City , in accordance with the terms, conditions and specifications contained in the IFB, at a cost not to exceed Six Hundred Ninety-Six Thousand Eight Hundred Twenty Dollars and Eight Cents (\$696,820.08), plus an additional project contingency amount of Sixty-Nine Thousand Six Hundred Eighty-Two Dollars and One Cent (\$69,682.01) to cover the cost of any unforeseen conditions or City requested changes, for a total cost not to exceed Seven Hundred Sixty-Six Thousand Five Hundred Three Dollars (\$766,503.00); and

WHEREAS, the Mayor and City Council have determined that it is in the City's best interest to approve the selection of Contractor and hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services to perform the water main project.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City administration's ranking and selection of Basile USA, LLC as the lowest, responsive and responsible contractor to perform the water main project on N.E. 118th Street from Biscayne Canal Road to West Dixie Highway, in accordance with the terms, conditions and specifications contained in *IFB No. 13-21-22 – Water Main Project on N.E. 118th Street from Biscayne Canal Road to West Dixie Highway.*


Section 2. **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services with Basile USA, LLC, at a cost not to exceed Seven Hundred Sixty-Six Thousand Five Hundred Three Dollars (\$766,503.00).

Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
