

RESOLUTION NO. 2022-R-69

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA APPROVING
THE EXECUTION OF A MEMORANDUM OF
UNDERSTANDING BETWEEN THE CITY OF NORTH
MIAMI AND PINELLAS COUNTY TO PROVIDE FOR THE
NORTH MIAMI POLICE DEPARTMENT'S ABILITY TO
ACCESS FLORIDA'S FACIAL RECOGNITION
NETWORK; PROVIDING FOR AN EFFECTIVE DATE AND
ALL OTHER PURPOSES.**

WHEREAS, the Pinellas County Sheriff's Office maintains the largest collaborative open model Face Recognition Network in the United States and exclusively hosts Florida's Facial Recognition Network ("FR-Net"); and

WHEREAS, FR-Net provides facial biometric search capabilities, subject information, face image comparison tools, training for facial recognition search, and face image analysis methods to authorized Florida law enforcement agencies; and

WHEREAS, the North Miami Police Department must enter into a Memorandum of Understanding ("MOU") with Pinellas County Sheriff's Office to access and make information available to the City to perform automated facial recognition searches and face image comparisons through the Face Analysis Comparison & Examination System Next ("FACESNXT"); and

WHEREAS, State and Local Law Enforcement agencies are qualified to enter into a mutual aid agreement with a law enforcement agency as authorized by the Florida Mutual Aid Act and Part I, Chapter 23, Florida Statutes; and

WHEREAS, the Mayor and City Council believe that the Memorandum of Understanding for access to FR-Net will benefit the residents of the City of North Miami and should be entered into.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**


Section 1. Approval of Agreement. The City Council hereby approves the Memorandum of Understanding between the City of North Miami and Pinellas County attached as "Exhibit 1."
