## OF PROPOSED ORDINANCE OF THE CITY OF NORTH MIAMI

**NOTICE IS HEREBY GIVEN** that the City of North Miami, Florida proposes to adopt the following Ordinances:

- (1) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING VOLUME 1: GOALS, OBJECTIVES AND POLICIES OF THE CITY OF NORTH MIAMI 2036 COMPREHENSIVE PLAN, SPECIFICALLY, BY AMENDING POLICY 1.2.1 AND POLICY 1.21.3 REVISING THE MAXIMUM HEIGHT IN THE BAYSHORE ZONE FROM ONE HUNDRED FIFTEEN (115) FEET TO ONE HUNDRED SIXTY-NINE (169) FEET; AND CHANGING THE OFFICIAL 2036 FUTURE LAND USE MAP DESIGNATION FROM LOW MEDIUM DENSITY RESIDENTIAL TO BAYSHORE ZONE FOR THE APPROXIMATELY 1.1 ACRE PROPERTY LOCATED AT 2305 NE 123RD STREET, AND SPECIFICALLY IDENTIFIED WITH MIAMI-DADE FOLIO NUMBER 06-2228-022-0010, AND BOUNDED BY NE 123RD STREET TO THE SOUTH, N. BAYSHORE DRIVE TO THE WEST AND BISCAYNE BAY TO THE NORTH AND EAST, IN ACCORDANCE WITH SECTION 163.3187, FLORIDA STATUTES (2021); AND ARTICLE 3, ENTITLED "DEVELOPMENT REVIEW", DIVISION 3, SECTION 3-302, SECTIONS 3-1104 THROUGH 3-1107, SECTION 3-1109, AND SECTION 3-1110, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES, CHAPTER 29, ENTITLED "LAND DEVELOPMENT REGULATIONS". *QUASI-JUDICIAL (FIRST READING)*

- IN ACCORDANCE WITH THE PROVISIONS OF SECTION 286.0105, FLORIDA STATUTES, ANYONE WISHING TO APPEAL ANY DECISION MADE BY THE CITY OF NORTH MIAMI CITY COUNCIL, WITH RESPECT TO ANY MATTER CONSIDERED AT SUCH MEETING OR HEARING, WILL NEED A RECORD OF THE PROCEEDINGS AND, FOR SUCH PURPOSE, MAY NEED TO ENSURE THAT A VERBATIM RECORD OF THE PROCEEDINGS IS MADE, INCLUDING THE TESTIMONY AND EVIDENCE UPON WHICH THE APPEAL IS TO BE BASED.
