

**RESOLUTION NO. 2022-R-79**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO BRYANT INTEGRATED TECHNOLOGIES, INC., IN AN AMOUNT NOT-TO-EXCEED THIRTY-THREE THOUSAND SIX HUNDRED SIXTY-EIGHT DOLLARS (\$33,668.00), FOR THE PROVISION OF BODY WORN CAMERA VIDEO DATA STORAGE FOR A SIX (6) MONTH PERIOD; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) police department is in the process of transitioning the body worn camera program to their new provider, Axon Enterprises, Inc. (“Axon”); and

**WHEREAS**, there is a significant amount of stored video data, approximately ninety-three (93) terabytes, which needs to be transferred to Axon’s cloud-based storage platform; and

**WHEREAS**, City staff recommends an extension to the current storage services provided by Genetec for a six (6) month period to allow the necessary time to complete the entire migration of video data to Axon; and

**WHEREAS**, the cloud-based storage services provided by Genetic are currently contracted through Bryant Integrated Technologies, Inc. (“Bryant Integrated”); and

**WHEREAS**, City staff is requesting the issuance of a purchase order to provide for a six (6) month extension of video data storage services provided by Genetic through Bryant Integrated for an amount not-to-exceed Thirty-Three Thousand Six Hundred Sixty-Eight Dollars (\$33,668.00); and


**WHEREAS**, the Mayor and City Council find that the extension of body worn camera video data storage services for a six (6) month period is in the best interest of the City and its residents and authorize the City Manager to issue purchase orders in support of this objective.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authorization to City Manager.** The Mayor and City Council of the City of North Miami, Florida hereby authorize the City Manager to issue purchase orders to Bryant Integrated Technologies, Inc., for an amount not-to-exceed Thirty-Three Thousand Six Hundred Sixty-Eight Dollars (\$33,668.00) for the purchase of body worn camera video data storage services for a six (6) month period.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
