

**RESOLUTION NO. 2022-R-91**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, GERARD  
KEVIN SEIFRIED TO THE CITIZENS' INVESTIGATIVE  
BOARD, IN ACCORDANCE WITH CHAPTER 2, ARTICLE  
III, DIVISION 12, SECTION 2-261, OF THE CITY OF  
NORTH MIAMI CODE OF ORDINANCES; PROVIDING  
FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the purpose of the North Miami Citizens' Investigative Board ("CIB") is to create a mechanism for external community fact-finding and dispute resolution and for the impartial review panel to conduct independent reviews and hold public hearings concerning complaints or grievances made against sworn officers of the North Miami Police Department; and

**WHEREAS**, Chapter 2, Article III, Division 12, Section 2-261, of the City of North Miami Code of Ordinances, states that the initial members of the CIB shall be comprised of members appointed by a nominating committee; and

**WHEREAS**, Chapter 12, Article III, Division 12, Section 2-261, of the City of North Miami Code of Ordinances, allows each member of the City Council to appoint one (1) member to the CIB, with one (1) member to be appointed by the mayor and council at-large; and

**WHEREAS**, members of the commission shall be all members of the CIB shall be qualified electors of the City of North Miami and possesses a reputation for civic pride, integrity, responsibility and have demonstrated an active interest in public affairs and service; and

**WHEREAS**, in accordance with Section 2-261 of the City Code, members should have diverse professional backgrounds with consideration being given to appointing a retired law enforcement officer and retired member of the judiciary, judge or magistrate, and retired or active professionals in the following fields: (1) human resources; (2) faith-based; (3) social justice; and (4) civil rights law with good reputations for integrity and community service and shall have no record of a felony conviction or any crime involving moral turpitude; and

**WHEREAS**, Vice Mayor Alix Desulme desires to appoint Gerard Kevin Seifried to the North Miami Citizens' Investigative Board.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY  
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.** **Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida and are incorporated herein.

**Section 2.** **Appointments.** The Mayor and City Council of the City of North Miami, Florida, hereby appoints Gerard Kevin Seifried to the North Miami Citizens' Investigative Board.

**Section 3.** **Effective Date.** This Resolution shall become effective immediately upon adoption.
