NOTICE OF FUNDING AVAILABILITY
STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM (SHIP)**

The Housing and Social Services Department (“HSS”) of the City of North Miami (“City”) hereby notifies the public of the availability of the State Housing Initiatives Partnership Program (“SHIP”) funding for its FY 2022-2023 allocated by the State through the Florida Housing Finance Corporation.

The City is an entitlement recipient of the SHIP program and has received an allocation of \$367,278.00 for FY 2022-2023. A portion of this allocation as listed below is designated by the City to assist low income qualified families with home repairs for their single-family unit as well as assistance for first-time homebuyers.

Owner-Occupied Home Rehabilitation Program **\$250,551.00**
Rehabilitation funding will be made available to owners of single-family residential units in need of repair who meet the program’s income eligibility criteria and occupancy requirements. The maximum assistance is up to \$25,000.00 per unit.

First-Time Homebuyer Program **\$30,000.00**
Down payment and/or closing cost funding assistance will be made available to prospective homebuyers who meet the program’s criteria and will be purchasing a dwelling unit within eligible areas of the City of North Miami. The maximum assistance is up to \$25,000.00 per purchase.

Disaster Assistance* **\$50,000.00**
Disaster funding assistance will be made available to residents following a disaster as declared by Executive Order by the President of the United States or the Governor of the State of Florida, and may be used for purchase of emergency supplies to weatherproof damaged home, interim repairs to prevent further damage, trees and debris removal required to make the housing unit habitable and who meet program’s guidelines.

Program Administration **\$36,727.00**
Funding set aside to coordinate, monitor, and implement the programs and to ensure all related SHIP criteria are met.

**This program will only be implemented in the event of a disaster using any funds that have not been encumbered or additional disaster funds that become available.*

SPACE IS LIMITED TO 11 ELIGIBLE APPLICANTS FOR THE TWO PROGRAMS COMBINED

Open Registration

Registration for the FY 2022-2023 state funded housing programs will begin on October 1st, 2022 through October 31st, 2022.

Only completed applications are accepted along with required documents. Applicants will be pre-qualified and selected through a lottery process at a date to be announced by the HSS department. Of the funding provided, a minimum of twenty (20) percent must be used to serve persons with special needs as defined in F.S. 420.0004(13). Priority will be given to persons with developmental disabilities, as defined in F.S. 393.063, with an emphasis on home modification, including technological enhancements and devices, which will allow homeowners to remain independent in their own homes and maintain the ownership.

QUALIFICATIONS

To be **eligible**, your home must be owner-occupied as the “primary homesteaded residence”, have no current Federal, State and/or City liens AND must meet the income eligibility criteria. The SHIP Program, in accordance with the provisions of F.S. 760.20-760.37 does not discriminate on the basis of race, creed, religion, color, age, sex, marital status, familial status, national origin, or handicap in the application process for eligible housing assistance.
