

RESOLUTION NO. 2022-R-124

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EXECUTION OF A FOOD SUPPLY SERVICES AGREEMENT, IN SUBSTANTIALLY THE ATTACHED FORM, BETWEEN THE CITY OF NORTH MIAMI AND VICTORY FOR YOUTH CORP. D/B/A/ SHARE YOUR HEART TO PROVIDE AND DELIVER FOOD SUPPLY AND FACILITATION SERVICES TO THE CITY OF NORTH MIAMI FOOD PANTRY IN AN AMOUNT NOT-TO-EXCEED ONE HUNDRED TWENTY THOUSAND DOLLARS AND 00/100 CENTS (\$120,000.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) and Victory for Youth Corp. d/b/a Share Your Heart, Inc. (“Share Your Heart”) are desirous of entering into a Food Supply Services Agreement (“Agreement”) for the purpose of establishing a mutual framework of food services provided to the City of North Miami (“NOMI”) Food Pantry located at Sunkist Grove Community Center; and

WHEREAS, the City is experiencing the same issue facing the entire nation in the disruption of the supply chain, and as such is having difficulty supplying the pantry with balanced inventory of foods; and

WHEREAS, Share Your Heart will provide and deliver on a bi-monthly basis six hundred (600) household bags of approximately eleven (11) pounds each bag of non-perishable food; and

WHEREAS, the Mayor and City Council believe that an Agreement for this purpose will benefit the residents of the City and should be entered into with Share Your Heart.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Agreement. The Mayor and City Council of the City of North Miami, Florida, hereby approve the Food Supply Services Agreement between the City of North Miami and Share Your Heart attached as “Exhibit 1.”

Section 2. Authority of City Manager. The City Manager is authorized to execute the Food Supply Services Agreement attached as “Exhibit 1” with Share Your Heart.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
