

**RESOLUTION NO. 2022-R-149**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA APPROVING THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY (“NMCRA”) FISCAL YEAR 2022-2023 BUDGET; AUTHORIZING THE CITY MANAGER TO TRANSMIT THE NMCRA FISCAL YEAR 2022-2023 BUDGET TO MIAMI-DADE COUNTY; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTION NECESSARY TO COMPLETE THE APPROVAL PROCESS FOR THE NMCRA FISCAL YEAR 2022-2023 BUDGET WITH MIAMI-DADE COUNTY; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Interlocal Cooperation Agreement (the “Agreement”) between the North Miami Community Redevelopment Agency (the “NMCRA”), the City of North Miami (the “City”) and Miami-Dade County (the “County”) requires, among other things, the NMCRA to annually adopt and transmit a budget and annual report to the City and County for review and approval by the City Council and Board of County Commissioners (the “BCC”), respectively; and

**WHEREAS**, the Agreement also requires that the annual budget for the NMCRA be adopted by the NMCRA and the City prior to review and approval by the BCC; and

**WHEREAS**, the Fiscal Year 2022-2023 Budget for the NMCRA is attached hereto as Exhibit “A” (the “NMCRA Fiscal Year 2022-2023 Budget”); and

**WHEREAS**, all the expenses included in the NMCRA Fiscal Year 2022-2023 Budget are in accordance with state law, interlocal agreements including the Agreement and the NMCRA Redevelopment Plan; and

**WHEREAS**, the NMCRA previously approved the NMCRA Fiscal Year 2022-2023 Budget; and

**WHEREAS**, the Mayor and City Council desire to approve the NMCRA Fiscal Year 2022-2023 Budget.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Recitals.** The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.


**Section 2.     Budget Approval.** The NMCRA Fiscal Year 2022-2023 Budget attached hereto as Exhibit "A" is hereby approved and adopted.

**Section 3.     Transmittal.** The City Manager is hereby authorized to transmit the NMCRA Fiscal Year 2021-2022 Budget to the County for review and approval.

**Section 4.     Authority of City Manager.** The City Manager is hereby authorized to take all action necessary to complete the approval process for the NMCRA Fiscal Year 2022-2023 Budget with the County.

**Section 5.     Effective Date.** This Resolution shall take effect immediately upon approval.
