

RESOLUTION NO. 2022-R-146

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING AND AUTHORIZING A NEW PROGRAMS, ACTIVITIES AND RENTAL FEE SCHEDULE FOR THE PARKS AND RECREATION DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) has a recreation programs, activities and rental fee schedule which is updated from time to time by the Parks and Recreation Department (“Parks Department”), in order to offset expenses incurred by the City hosting recreational programs, activities and the rental of facilities (“Fee Schedule”); and

WHEREAS, the Parks Department completed a review of the current Fee Schedule, taking into consideration such factors as increasing costs, revenues, and fees charged by neighboring municipalities for recreational programs, activities and the use of facilities; and

WHEREAS, based on the information obtained, the Parks Department is proposing to make several adjustments to the Fee Schedule, in order to increase the number of program participants, increase the availability and number of facilities for rental, and increase total revenues to offset expenses incurred by the City; and

WHEREAS, the Mayor and City Council find that the proposed Fee Schedule (attached hereto as “Exhibit A”) is fair, reasonable and essential for the continued provision of high-quality recreational programs and activities, focusing on the public’s health, safety and welfare.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. Adoption of Fee Schedule. The Mayor and City Council of the City of North Miami, Florida, hereby approve and authorize a new programs, activities and rental fee schedule for the Parks and Recreation Department, attached hereto as “Exhibit A”.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
