

RESOLUTION NO. 2022-R-135

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO JET-VAC EQUIPMENT COMPANY, LLC AND SOUTHERN SEWER EQUIPMENT SALES , IN AN AMOUNT NOT TO EXCEED TWO HUNDRED THIRTY THOUSAND DOLLARS (\$230,000.00) ANNUALLY FOR A TERM OF FOUR (4) YEARS, FOR THE LEASE PURCHASE OF VAC-TRUCK AND STREET SWEEPER EQUIPMENT, UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF THE CITY CODE, ON CONTRACTS AWARDED THROUGH THE SOURCEWELL NATIONAL PURCHASING COOPERATIVE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, Sourcewell is a national purchasing cooperative which offers opportunities for member agencies to procure quality products/equipment and services as needed; and

**WHEREAS**, Sourcewell, issued two competitive (2) solicitations: *Request for Proposals No. 101221 - Sewer Vacuum, Hydro-Excavation, and Municipal Pumping Equipment with Related Accessories and Supplies* and *Request for Proposals No. 093021 Street Sweepers and Specialty Sweepers, with Related Equipment, Accessories, and Supplies* seeking proposals from experienced and qualified vendors to provide sewer vacuum and street sweeper equipment; and

**WHEREAS**, as a result of these competitive solicitations, Sewer Equipment Co. of America and Global Environmental Products, Inc. (“Vendors”) were selected as part of a pool of vendors to provide the necessary equipment for a four (4) year term ending in November of 2025; and

**WHEREAS**, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

**WHEREAS**, Jet-Vac Equipment Company, LLC and Southern Sewer Equipment Sales (“Suppliers”) are the authorized distributors in South Florida for the Vendors, respectively; and

**WHEREAS**, in accordance with Section 7-169 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the City Manager to issue purchase orders to the Suppliers for the provision of a vac-truck and street sweeper equipment in an amount

not to exceed Two Hundred Thirty Thousand Twenty Dollars (\$230,000.00) annually, based on Sourcewell Contracts No. 101221-SCA and No. 0093021-GEP, respectively; and

**WHEREAS**, the Mayor and City Council find the purchase of the equipment at a substantial savings, in accordance with the Solicitation, is in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1. Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to Jet-Vac Equipment Company, LLC and Southern Sewer Equipment Sales, at a cost not to exceed Two Hundred Thirty Thousand Dollars (\$230,000.00) on an annual basis for a four (4) year term, utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code, based on Sourcewell Contracts No. 101221-SCA and No. 0093021-GEP, respectively.

**Section 2. Effective Date.** This Resolution shall be effective upon adoption.
