**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING
THE SUBMITTAL OF A GRANT APPLICATION AND
AUTHORIZING THE CITY MANAGER AND CITY
ATTORNEY TO NEGOTIATE AND EXECUTE AN
AGREEMENT BETWEEN THE CITY OF NORTH MIAMI
AND THE UNITED STATES DEPARTMENT OF JUSTICE
FOR GRANT FUNDS FROM THE 2022 EDWARD BYRNE
MEMORIAL JUSTICE ASSISTANCE (“JAG”) GRANT
PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND
ALL OTHER PURPOSES.**

WHEREAS, the Mayor and City Council are desirous of securing a grant from the 2022 Edward Byrne Memorial Justice Assistance (“JAG”) Grant Program; and

WHEREAS, the City of North Miami (“City”) is requesting a grant for a project at a total cost of Forty-Two Thousand One Hundred Fifty-Eight Dollars (\$42,158.00) in grant funds with no required match; and

WHEREAS, the funds will be utilized toward the City’s compliance with the National Incident-Based Reporting System (“NIBRS”) and to improve the efficiency of the police communications division by enhancing their ability to retrieve and process vital information across records management and dispatching systems; and

WHEREAS, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the United States Department of Justice for the purpose of securing grant funds.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the submittal of an application to the United States Department of Justice for a 2022 Edward Byrne Memorial Justice Assistance Grant (“JAG”) Program Grant.

Section 2. Authority to City Manager and City Attorney. The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida, and the United States Department of Justice.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
