

**RESOLUTION NO. 2022-R-128**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING  
THE NORTH MIAMI LIBRARY'S STRATEGIC  
MANAGEMENT PLAN FOR FISCAL YEARS 2022-2025;  
PROVIDING FOR AN EFFECTIVE DATE AND ALL  
OTHER PURPOSES.**

**WHEREAS**, the North Miami Library's mission is to provide open and free access to information and technology while fostering independent lifelong learning, personal growth and development, intellectual stimulation, cultural enrichment, and a love of reading; and

**WHEREAS**, the State Aid to Library Grant Program is an important component of providing library services to the citizens of North Miami; and

**WHEREAS**, as part of its application to the State Aid to Library Grant Program, the City is required to submit a Strategic Management Plan for the North Miami Library; and

**WHEREAS**, in the Library's Strategic Management Plan, the Library has several goals it plans on accomplishing including: Increase the Library's presence in the community; Raise the Library's profile and services to serve and energize the community; Create an information-literate community; Support lifelong learning; Increase the level of awareness of Library services among all segments of the community; and Create strong and effective ways of conducting the Library's business; and

**WHEREAS**, the City Administration has reviewed the North Miami Library's Strategic Management Plan, attached as Exhibit "1", and recommends its approval.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

**Section 1. Approval.** The Mayor and City Council hereby approves the North Miami Library's Strategic Management Plan, attached as "Exhibit 1."

**Section 2. Effective Date.** This Resolution will be effective immediately upon adoption.
