**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE EXECUTION OF A LANDSCAPE,
IRRIGATION, AND TURF MAINTENANCE
MEMORANDUM OF AGREEMENT BETWEEN THE CITY
OF NORTH MIAMI AND THE FLORIDA DEPARTMENT
OF TRANSPORTATION, DESIGNATING AND SETTING
FORTH THE RESPONSIBILITIES OF EACH PARTY WITH
REGARDS TO THE MAINTENANCE OF FUTURE
LANDSCAPE IMPROVEMENTS ON STATE ROAD (SR)
916/N.W/N.E 135 STREET, FROM N.W 6 AVENUE TO SR
5/BISCAYNE BOULEVARD; PROVIDING FOR AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the Florida Department of Transportation (“FDOT”) has drafted design plans for beautification on SR-916 (135th Street) from N.W 6th Avenue to Biscayne Boulevard (the “Project”); and

WHEREAS, FDOT will construct landscape and turf improvements in accordance with the design plans corresponding to Financial Project ID 429346-4-52-01; and

WHEREAS, the City agrees to the installation of landscaping, turf, and irrigation on FDOT Right-of-Ways as part of the Beautification Project and will also accept responsibility for the ongoing maintenance of the installed improvements; and

WHEREAS, the Mayor and City Council find that entering into a Landscape, Irrigation, and Turf Maintenance Memorandum of Agreement, in substantially the attached form, for the maintenance and preservation of the beautification improvements, is in the best interest of the City and should be entered into.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

Section 1. Authorization. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the execution of a Landscape, Irrigation, and Turf Maintenance Memorandum of Agreement between the City of North Miami and Florida Department of Transportation, designating and setting forth the responsibilities of each party with regards to the maintenance of future landscape improvements on State Road 916 (N.E/N.W 135th Street) from N.W 6th Avenue to State Road 5 (Biscayne Boulevard).

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
