

RESOLUTION NO. 2022-R-170

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, ESTABLISHING THE SALARY OF THE MAYOR AND COUNCIL IN ACCORDANCE WITH SECTION 12 OF THE CITY CHARTER; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, section 12 of the City of North Miami Charter states that the city council will determine the annual salary of the mayor and councilmembers by resolution which cannot exceed the budgeted amount; and

WHEREAS, the City of North Miami (“City”) adopted the 2022-2023 Fiscal Year Budget on September 28, 2022 as provided for in Ordinance No.1486; and

WHEREAS, the 2022-2023 City Budget provides for an increase in the budgeted amount allocated for Mayor and Council salaries; and

WHEREAS, the Mayor and Council find that the proposed salary adjustments do not exceed the budgeted amount and are appropriate.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Salary of the Mayor.** Commencing October 1, 2022, the annual salary of the Mayor shall be \$89,880.00. This annual salary shall be subject to future review and change as provided by resolution of the Mayor and City Council.

**Section 2. Salary of the City Councilmembers.** Commencing October 1, 2022, the annual salary of the Councilmembers shall be \$77,910.00 This annual salary shall be subject to future review and change as provided by resolution of the Mayor and City Council.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
