

RESOLUTION NO. 2022-R-167

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A REHABILITATION AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND REGOSA ENGINEERING SERVICES, INC. FOR THE EXPENDITURE OF FORTY-SEVEN THOUSAND TWO HUNDRED FIFTY-ONE DOLLARS AND 50/100 CENTS (\$47,251.50) TOWARD A NEIGHBORHOOD STABILIZATION PROGRAM (“NSP”) MULTIFAMILY UNIT REHABILITATION PROJECT LOCATED AT 401 NE 121 STREET, UNIT 202, NORTH MIAMI, FL; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) owns certain property located at 401 NE 121st Street consisting of nine (9) units which contains numerous health and life safety issues and is in need of rehabilitation; and

WHEREAS, the scope of the rehabilitation project (“Project”) includes improvements to the interior of the unit including floor replacement, reparation of windows and doors, interior paint, interior renovation of the kitchen and bathrooms as well as general repairs to prepare the unit for move-in; and

WHEREAS, the rehabilitation costs for the Project will total Forty-Seven Thousand Two Hundred Fifty-One Dollars and 50/100 Cents (\$47,251.50); and

WHEREAS, pursuant to Section 7-129 of the North Miami Code of Ordinances, the City Manager is authorized to recommend to the City Council all contract awards more than Twenty-Five Thousand Dollars and 00/100 Cents (\$25,000.00); and

WHEREAS, the Mayor and City Council find that entering into a Rehabilitation Agreement, in substantially the attached form, for the rehabilitation and improvements to the property located at 401 NE 121st Street, Unit 202, is in the best interest of the City.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Expenditure. The Mayor and City Council hereby authorize the expenditure of funds not to exceed Fifty Thousand Dollars and 00/100 Cents (\$50,000.00) toward the rehabilitation of the property located at 401 NE 121st Street, Unit 202.

Section 2. Authority of City Manager. The Mayor and City Council of the City of North Miami hereby authorize the City Manager to execute the Rehabilitation Agreement between the City of North Miami and Regosa Engineering Services, Inc., attached as Exhibit "A."

Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
