

RESOLUTION NO. 2022-R-165

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE CITY MANAGER'S EMERGENCY PROCUREMENT AND ISSUANCE OF A PURCHASE ORDER TO APEX-TECH ELECTRICAL & AIR CONDITIONING, INC., IN AN AMOUNT NOT-TO-EXCEED THIRTY-SEVEN THOUSAND TWO HUNDRED DOLLARS (\$37,200.00), FOR THE EMERGENCY REPLACEMENT OF THE MULTI-PURPOSE ROOM AIR CONDITIONING UNIT AT THE NORTH MIAMI PUBLIC LIBRARY; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, it was determined that the air conditioning unit at the multi-purpose room of the North Miami Public Library was beyond repair and needed to be replaced in time to accommodate the facility's use as an early voting site for the upcoming general election; and

WHEREAS, it was imperative that all repairs be completed prior to early voting as the library's multi-purpose room will not be able to accommodate the amount of power needed for the election's equipment and multiple spot coolers and once the elections equipment has been placed by the elections department, library staff and contractors will not be able to access the room until the elections are completed; and

WHEREAS, Section 7-144, City Code, allows the City Manager to make emergency procurements when there exists an immediate threat to public health, welfare, or safety or to prevent or minimize serious disruption of government services; and

WHEREAS, it was determined that the most appropriate course of action was to issue a purchase order to Apex-Tech Electrical & Air Conditioning, Inc., in an amount not-to-exceed Thirty-Seven Thousand Two Hundred Dollars (\$37,200.00), on an emergency basis, for the replacement of the air conditioning unit at the North Miami Public Library; and

WHEREAS, City administration respectfully requests that the Mayor and City Council ratify the issuance of the purchase order, pursuant to Section 7-144, City Code of Ordinances.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the City Manager's issuance of a Purchase Order in the amount not-to-exceed

Thirty-Seven Thousand Two Hundred Dollars (\$37,200.00) to Apex-Tech Electrical & Air Conditioning, Inc. for the emergency replacement of the air conditioning unit at the North Miami Public Library, pursuant to Section 7-144, City Code of Ordinances.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
