



# PUBLIC NOTICE

## OF PROPOSED ORDINANCE OF THE CITY OF NORTH MIAMI

**NOTICE IS HEREBY GIVEN** that the City of North Miami, Florida proposes to adopt the following Ordinances:

- (1) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING CHAPTER 7 OF THE CODE OF ORDINANCES ENTITLED, "FINANCE", AT ARTICLE III, ENTITLED "PROCUREMENT CODE" BY AMENDING DIVISION 1, SPECIFICALLY AT SECTION 7-121 ENTITLED "EXEMPTIONS" TO PROVIDE FOR THE EXEMPTION OF TELECOMMUNICATIONS AND INTERNET SERVICES FROM THE PROCUREMENT PROCESS; PROVIDING FOR REPEAL, CONFLICTS, SEVERABILITY, CODIFICATION AND FOR AN EFFECTIVE DATE. **(SECOND READING)**
- (2) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AMENDING SECTIONS 10, 36 AND 58 OF THE CITY CHARTER, TO CHANGE THE DATE OF THE GENERAL ELECTION FROM MAY 9, 2023 TO NOVEMBER 5, 2024 AND TO CHANGE THE DATE OF ALL SUBSEQUENT ELECTIONS; PROVIDING FOR THE EXTENSION OF EXISTING TERMS OF OFFICE; ADOPTING SUCH CHARTER AMENDMENTS PURSUANT TO SECTIONS 100.3605(2) AND 166.021(4), FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CHARTER/CONFORMITY OF AMENDMENTS; PROVIDING FOR REPEAL OF CONFLICTING PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE. **(SECOND READING)**
- (3) AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, ELECTIONS", BY AMENDING ARTICLE IV, ENTITLED "ELECTION ADMINISTRATION" SPECIFICALLY AT SECTION 6-76, ENTITLED "DATES OF ELECTIONS" TO CHANGE THE DATES FOR REGULAR ELECTIONS FROM MAY IN ODD-NUMBERED YEARS TO NOVEMBER IN EVEN-NUMBERED YEARS TO COINCIDE WITH NATIONAL AND GUBERNATORIAL ELECTIONS; CHANGING THE DATE OF THE RUNOFF ELECTION; PROVIDING FOR REPEAL, CONFLICTS, SEVERABILITY, CODIFICATION, AND AN EFFECTIVE DATE. **(SECOND READING)**
