

**RESOLUTION NO. 2020-R-182**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND EBS ENGINEERING, INC., FOR TRAFFIC CIRCLE DESIGN AND CONSTRUCTION PHASE ENGINEERING SERVICES FOR THE INTERSECTION LOCATED AT N.E. 141 STREET AND N.E. 5<sup>TH</sup> AVENUE, AT A COST NOT TO EXCEED FIFTY-FIVE THOUSAND FIVE HUNDRED FIFTY-ONE DOLLARS (\$55,551.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on December 7, 2017, the City advertised *Request for Qualifications No. 08-17-18, Continuing Professional Architectural & Engineering Services* (“RFQ”), for the purpose of retaining a pool of experienced, licensed and insured architectural and engineering firms to provide on a continuing as-needed, when needed basis, the following specific services: Architecture, Landscape Architecture, Civil Engineering, Planning and Urban Design, Roadway, Traffic and Transportation Engineering and Consulting, Water/Waste Water Engineering, Water Resources and Stormwater Design and Environmental Engineering (“Services”); and

**WHEREAS**, the RFQ was undertaken in accordance with Florida’s Consultants’ Competitive Negotiation Act, under Section 287.055, Florida Statutes; and

**WHEREAS**, in response to the RFQ, EBS Engineering, Inc. (“Consultant”) submitted its qualifications for the provision of Transportation/Traffic Engineering & Consulting services and was approved to be included on the City’s list of pre-qualified firms pursuant to Resolution No. 2019-R-15; and

**WHEREAS**, the proposed project requires services consisting of performing roadway design improvements to add a traffic circle at the intersection of N.E. 141 Street and N.E. 5<sup>th</sup> Avenue; and

**WHEREAS**, services will include: a Feasibility Study including Pre-Design Development Phase, survey of entire right-of-way, drainage survey, Design Services with Final Construction Drawings, and Construction Engineering Inspection services including bid and award phase and Construction Phase and Project Close-out Services for total fee not to exceed Fifty-Five Thousand Five Hundred Fifty-One Dollars (\$55,551.00); and

WHEREAS, the City administration respectfully requests that the Mayor and City Council authorize the City manager and City Attorney to negotiate and execute an agreement with Consultant for the provision of Services, relating to the traffic circle installation project.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

**Section 1. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement between the City of North Miami and EBS Engineering Inc., for traffic circle design and construction phase engineering services for the intersection located at N.E. 141 Street and N.E. 5<sup>th</sup> Avenue, at a cost not to exceed Fifty-Five Thousand Five Hundred Fifty-One Dollars (\$55,551.00).

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
