

RESOLUTION NO. 2022-R-175

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF SOUTH FLORIDA LIGHTING TEAM, LLC D/B/A MIAMI CHRISTMAS LIGHTS, AS THE LOWEST, RESPONSIVE AND RESPONSIBLE VENDOR FOR THE INSTALLATION AND REMOVAL OF HOLIDAY LIGHTING AT CITY FACILITIES, IN ACCORDANCE WITH THE TERMS, CONDITIONS AND SPECIFICATIONS CONTAINED IN INVITATION TO QUOTE NO. 64-21-22; FURTHER AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO THE SELECTED VENDOR FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED FORTY-ONE THOUSAND FOUR HUNDRED FIFTY-TWO DOLLARS (\$41,452.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on July 29, 2022, the City of North Miami (“City”) advertised *Invitation to Quote No. 64-21-22 – Installation and Removal of Holiday Lighting* (“ITQ”), requesting quotes from qualified and experienced vendors to provide the City with installation and removal of holiday light displays for City Hall, Library, Pioneer Boulevard and Joe Celestin Center for the benefit of our local community and visitors alike, in accordance with the specifications and conditions contained in the ITQ (collectively referred hereto as “Services”); and

WHEREAS, in response to the ITQ, the City received five (5) quotes and South Florida Lighting Team, LLC d/b/a Miami Christmas Lights (“Vendor”) was competitively selected as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the Vendor has manifested the capability and willingness of providing Services to the City, in accordance with the terms, conditions and specifications contained in the ITQ, at a cost not to exceed Forty-One Thousand Four Hundred Fifty-Two Dollars (\$41,452.00); and

WHEREAS, the Mayor and City Council have determined that it is in the City’s best interest to approve the selection of Vendor and hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services to install holiday lighting at City facilities.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City administration's selection of South Florida Lighting Team, LLC d/b/a Miami Christmas Lights as the lowest, responsive and responsible Vendor to install and remove holiday lighting at City facilities, in accordance with the terms, conditions and specifications contained in *ITQ No. 64-21-22 – Installation and Removal of Holiday Lighting*.

Section 2. **Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to South Florida Lighting Team, LLC d/b/a Miami Christmas Lights for the provision of Services, at a cost not to exceed Forty-One Thousand Four Hundred Fifty-Two Dollars (\$41,452.00).


Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
