

RESOLUTION NO. 2022-R-215

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO TYLER TECHNOLOGIES, INC., TO PROVIDE UPGRADED EQUIPMENT FOR THE EXECUTIME DIGITAL PAYROLL AND BIOMETRIC TIME ATTENDANCE SOFTWARE SYSTEM, AT A COST NOT TO EXCEED ONE HUNDRED EIGHTEEN THOUSAND NINE HUNDRED THIRTY DOLLARS (\$118,930.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami, Florida (“City”) and Tyler Technologies, Inc. (“Tyler”) entered into an agreement to provide the enterprise-wide software including software licenses, warranties, user manuals, maintenance, installation, and training; and

WHEREAS, on January 26, 2016, the City Council adopted Resolution No. 2016-R-10, which authorized an amendment to the agreement with Tyler for the implementation of the Executime software and equipment for the use of digital payroll and biometric (fingerprint) time attendance system; and

WHEREAS, Tyler is the exclusive and proprietary source of the Executime Software and equipment; and

WHEREAS, the City’s Information and Technology Department has determined that the current Executime software has outlived its maintenance and warranty and therefore, now needs to be replaced; and

WHEREAS, the City desires the purchase of upgraded equipment to ensure the continued provision of enterprise-wide software and biometric time and attendance maintenance services from Tyler, at a cost not to exceed One Hundred Eighteen Thousand Nine Hundred Thirty and no/100 Dollars (\$118,930.00); and

WHEREAS, City Administration respectfully requests that the City Council authorize the City Manager to issue purchase orders to Tyler in the above listed amount in order to continue the provision of said services.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The City Council of the City of North Miami, Florida, hereby authorizes the City Manager to issue purchase orders to Tyler in an amount not to exceed (\$118,930.00) to provide upgraded equipment for the Executive digital payroll and biometric time attendance software system.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
