

RESOLUTION NO. 2022-R-210

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, DECLARING TWO (2) COLT M16 A1 RIFLES AS SURPLUS PROPERTY IN ACCORDANCE WITH SECTION 7-145 OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; FURTHER AUTHORIZING THE CITY MANAGER TO SELL THE SURPLUSED ITEMS TO DEALERNFA, INC. FOR THE ESTIMATED FAIR MARKET PRICE OF FIFTY THOUSAND DOLLARS (\$50,000.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) owns two (2) Colt M16 A1 rifles (“Property”) that were previously used by the North Miami Police Department’s (“NMPD”) Special Weapons and Tactics (“SWAT”) team; and

WHEREAS, the two (2) Colt M16 A1 rifles were purchased in 1980 and have become outdated, posing a safety issue if continued in service; and

WHEREAS, the estimated fair market value of the two (2) Colt M16 A1 rifles is twenty-five thousand dollars (\$25,000.00) and DEALERNFA, Inc. has expressed their willingness to purchase both rifles for a total purchase price of fifty thousand dollars (\$50,000.00); and

WHEREAS, pursuant to Section 7-145 of the City Code, all surplus items with an estimated fair market value of twenty-five thousand dollars (\$25,000.00) or more must be declared surplus by a resolution of the City Council before the City Manager of the Purchasing Department may dispose of said surplus property; and

WHEREAS, the City Administration is respectfully requesting that the City Council authorize the surplus of the Property and declare the disposal of the Property by selling it at fair market value to DEALERNFA, Inc.; and

WHEREAS, the City Council desires to declare as surplus, the aforementioned property; make said surplus property available for sale to DEALERNFA, Inc. for a total purchase price of fifty thousand dollars (\$50,000.00).


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Declaration of Surplus.** The City Council of the City of North Miami hereby declares two (2) Colt M16 A1 rifles as surplus property.


Section 2. **Authority of City Manager.** The City Council of the City of North Miami hereby authorizes the City Manager to dispose of the surplus property by selling it to DEALERNFA, Inc. for fifty thousand dollars (\$50,000.00).

Section 3. **Effective Date.** This Resolution shall be effective immediately upon adoption.
