

**RESOLUTION NO. 2022-R-209**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE EXECUTION OF A LETTER OF UNDERSTANDING, IN SUBSTANTIALLY THE ATTACHED FORM, BETWEEN THE MIAMI-DADE COUNTY DEPARTMENT OF CULTURAL AFFAIRS THROUGH ITS ART IN PUBLIC PLACES PROGRAM AND THE CITY OF NORTH MIAMI FOR THE PROVISION OF ADMINISTRATIVE SERVICES FOR THE CITY'S ART IN PUBLIC PLACES PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami ("City") is desirous of creating a partnership with the Miami-Dade County Department of Cultural Affairs (the "County") to enlist the County's assistance in administering the City's Art in Public Places Program ("AIPP") as it relates to specified projects; and

**WHEREAS**, the County has submitted its proposal to provide AIPP administrative services, along with an estimated budget and tentative timeline for the "Manor Biscayne Development Project"; and

**WHEREAS**, the City and the County are desirous of entering into a Letter of Understanding with each other to explore a potential working relationship related to the administration of the City's AIPP program as applied to specified projects and mutual objectives established as priorities by both Parties; and

**WHEREAS**, in accordance with the terms of the Letter of Understanding, the County will provide the City with administrative and support services in the administration of the City's AIPP as it relates to the Manor Biscayne Development Project for an amount not to exceed ten percent (10%) of the final AIPP allocation for the project; and

**WHEREAS**, City administration has reviewed the proposal and recommends the provisions of AIPP administrative support services through the County; and

**WHEREAS**, the City Council believe that a Letter of Understanding for this purpose will benefit the residents of the City and should be entered into with the County.



**Section 1. Approval of Letter of Understanding.** The City Council of the City of North Miami, Florida, hereby approve the Letter of Understanding between the City of North Miami and the Miami-Dade County Department of Cultural Affairs through its Art in Public Places Program, attached as "Exhibit A."


**Section 2. Authority of City Manager.** The City Manager is authorized to execute the Letter of Understanding attached as "Exhibit A" with the Miami-Dade County Department of Cultural Affairs through its Art in Public Places Program.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
