

**RESOLUTION NO. 2022-R-208**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, DECLARING NO OBJECTION AND SUPPORTING THE HONORARY DESIGNATIONS BY THE FLORIDA LEGISLATURE DESIGNATING FLORIDA TRANSPORTATION FACILITIES (“ROADWAYS”) LOCATED WITHIN THE CITY OF NORTH MIAMI, PURSUANT TO SENATE BILL 160; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, Florida Statute 334.071 entitled “Legislative Designation of Transportation Facilities” states that erection of markers shall be contingent upon the appropriate city or county commissioner, passing a resolution in support of the particular honorary designation; and

**WHEREAS**, pursuant to the request made by the Florida Legislature for honorary designation of roads located within the City of North Miami (“City”), the City Council has no objection to the honorary designations and supports Senate Bill 160; and

**WHEREAS**, Senate Bill 160, adopted by the Florida Legislature, approved by the Governor on May 9, 2022, and codified under Chapter 2022-224 of the Laws of Florida, designated state transportation facilities (“roadways”) that are located within the City as follows: That portion of S.R. 826/Sunny Isles Boulevard between N.E. 35th Avenue and S.R. A1A in Miami-Dade County is designated as “Anthony Reznik Boulevard”; and

**WHEREAS**, the underlying legislation directs the Florida Department of Transportation to erect suitable markers for these street designations; and

**WHEREAS**, the City Manager respectfully requests that the City Council declare no objection and support the aforementioned honorary designations by the State of Florida Legislature.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Approval of Street Designation.** The City Council of the City of North Miami, Florida, hereby declare no objection and support the honorary designations by the Florida Legislature designating Florida Transportation Facilities (“Roadways”) located within the City of North Miami, Pursuant to Senate Bill 160.

**Section 2.      Directions to City Clerk.** The City Clerk shall forward a copy of this Resolution to the Florida Department of Transportation (“FDOT”) and to the appropriate officials of Miami-Dade County.

**Section 3.      Effective Date.** This Resolution shall become effective immediately upon adoption.
