

**RESOLUTION NO. 2023-R-03**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO CDW GOVERNMENT, LLC, IN AN AGGREGATE AMOUNT NOT TO EXCEED TWENTY-NINE THOUSAND SEVEN HUNDRED FIFTY-ONE DOLLARS (\$29,751.00), FOR THE PURCHASE OF INFORMATION TECHNOLOGY INFRASTRUCTURE FOR THE SCOTT GALVIN COMMUNITY CENTER, UTILIZING THE COOPERATIVE PURCHASING PROVISION PURSUANT TO SEC. 7-169 OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, City of North Miami (“City”) staff has determined that it is necessary to install and implement the necessary technology infrastructure for the Scott Galvin Community Center to enable City staff to effectively utilize all office spaces and support critical systems, such as security cameras, telephones and computers, and will facilitate the use of amenities that the public can also benefit from such as the use of Wi-Fi and smart services like connected gym equipment; and

**WHEREAS**, City staff has received a quote from CDW Government, LLC (“CDW”) utilizing two (2) separate contracts issued by the following national purchasing cooperatives: 1) Sourcewell cooperative contract issued pursuant to RFP #081419 for TECHNOLOGY CATALOG SOLUTIONS and, 2) OMNIA Partners (National IPA) cooperative contract issued pursuant to RFP #2018011 for INFORMATION TECHNOLOGY SOLUTIONS & SERVICES; and

**WHEREAS**, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

**WHEREAS**, in accordance with Section 7-169 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the City Manager to issue purchase orders to CDW for the provision of information technology infrastructure in an amount not to exceed Twenty-Nine Thousand Seven Hundred Fifty-One Dollars (\$29,751.00), based on a competitive price to the City; and


**WHEREAS**, the Mayor and City Council find the cooperative purchase of technology equipment at a substantial savings is in the best interest of the City.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1.**    **Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to CDW Government, LLC in the aggregate amount not to exceed Twenty-Nine Thousand Seven Hundred Fifty-One Dollars (\$29,751.00), utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code.

**Section 2.**    **Effective Date.** This Resolution shall be effective upon adoption.
