

RESOLUTION NO. 2023-R-42

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND GPE ENGINEERING & GENERAL CONTRACTOR CORP., TO INCLUDE ADDITIONAL SERVICES FOR COMPLETION OF THE CITYWIDE SIDEWALK REPAIRS PROJECT, AT AN ADDITIONAL COST NOT TO EXCEED TWO HUNDRED THOUSAND DOLLARS (\$200,000.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, On December 14, 2021, Mayor and City Council adopted Resolution No. 2021-R-185 authorizing the negotiation of an agreement with GPE Engineering & General Contractor Corp. (“GPE”) for the provision of citywide sidewalk repair services in an amount not-to-exceed Two Hundred Thousand Dollars (\$200,000.00) annually; and

WHEREAS, in order to address the sidewalk maintenance needs of the City, the Public Works department is requesting an increase to services provided by GPE resulting in an increase to the total dollar amount of the current agreement by an additional Two Hundred Thousand Dollars (\$200,000); and

WHEREAS, the amended agreement will reflect a revised total contract amount of Four Hundred Thousand Dollars (\$400,000) with all other terms and conditions remaining the same; and

WHEREAS, the City Administration respectfully requests that the Mayor and City Council authorize an amendment to the Agreement to include additional services for the aforementioned reasons, benefitting the City.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an amendment to the agreement between the City of North Miami and GPE Engineering & General Contractor Corp., to include additional services, at a cost not-to-

exceed Two Hundred Thousand Dollars (\$200,000.00), resulting in a revised total contract amount of Four Hundred Thousand Dollars (\$400,000.00).

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
