**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
APPOINTING LUMANA JOSEPH TO GROUP A OF THE
PERSONNEL BOARD, IN ACCORDANCE WITH CHAPTER
15, ARTICLE 1, SECTION 15-4, OF THE CITY OF NORTH
MIAMI CODE OF ORDINANCES; PROVIDING FOR AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the Personnel Board hears appeals of employees in the classified service who are suspended, reduced, or removed and reports its findings and recommendations to the City Manager and reviews the activities of the personnel department makes recommendations; and

WHEREAS, in accordance with Chapter 15, Article 1, Section 15-4, of the City of North Miami Code of Ordinances, appointment to Group A shall be made by the Mayor; and

WHEREAS, the Personnel Board shall consist of six (6) members who shall be a qualified voter of the city and shall be known to be in sympathy with the merit principle as applied to the civil service; and

WHEREAS, Mayor Alix Desulme desires to appoint Lumana Joseph to Group A of the Personnel Board.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Recitals. The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

Section 2. Appointments. The Mayor of the City of North Miami, Florida, hereby appoints Lumana Joseph to Group A of the Personnel Board.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
