

RESOLUTION NO. 2023-R-76

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY, TO SECURE A GRANT FROM THE COMPETITIVE FLORIDA PARTNERSHIP GRANT PROGRAM; PROVIDING FOR AN EFFECTIVE DATE, AND ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and City Council are desirous of securing a grant from the Florida Department of Economic Opportunity; and

**WHEREAS**, the City of North Miami (“City”) is requesting a grant in the amount of Forty-Six Thousand Dollars and No Cents (\$46,000.00) with no required match for a total project cost in the amount of Forty-Six Thousand Dollars and No Cents (\$46,000.00); and

**WHEREAS**, funds will be used to assist in the development of the “Building Economic Equity in North Miami” economic action plan; and

**WHEREAS**, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the Florida Department of Economic Opportunity.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

**Section 1. Ratification of Submittal of Application.** The Mayor and City Council hereby ratify the submittal of the City of North Miami’s application for a grant from the Florida Department of Economic Opportunity in support of a grant from the Competitive Florida Partnership Grant Program.

**Section 2. Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida, and the Florida Department of Economic Opportunity to obtain grant funds.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
