

RESOLUTION NO. 2023-R-89

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING CHANGE ORDERS TO THE EXISTING PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND BLDM USA, LLC, FOR ADDITIONAL SERVICES FOR THE REHABILITATION OF WASTEWATER PUMP STATION “A” PROJECT, IN AN AMOUNT NOT TO EXCEED THREE HUNDRED EIGHT THOUSAND THREE HUNDRED EIGHTY-FOUR DOLLARS AND FORTY-ONE CENTS (\$308,384.41), PURSUANT TO INVITATION FOR BID NO. 55-20-21; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on October 12, 2021, the City of North Miami (“City”) adopted Resolution No. 2021-R-140, approving the selection of BLDM USA, LLC (“Contractor”) and authorized the City Manager to negotiate and execute an agreement between the City of North Miami and Contractor, to provide all labor, equipment, materials, services, and expertise required to complete the rehabilitation of Wastewater Pump Station “A” (the “Services”) in accordance with *Invitation for Bid No. 55-20-21 – Rehabilitation of Pump Station No. “A”*; and

WHEREAS, the summary of change orders consists of additional services required due to various issues encountered by **BLDM** since the commencement of the work; and

WHEREAS, the proposed additional services have been reviewed by staff and recommended for approval by the project engineer, **AECOM**, at a cost not to exceed Three Hundred Eight Thousand Three Hundred Eighty-Four Dollars and Forty-One Cents (\$308,384.41); and

WHEREAS, City administration respectfully requests approval for the additional expenditure of funds to ensure the timely completion of the project; and

WHEREAS, City administration respectfully requests that the Mayor and City Council authorize the proposed change orders to the existing agreement with the Contractor for the provision of Services, relating to the Wastewater Pump Station “A” project; and


WHEREAS, the Mayor and City Council of the City of North Miami, Florida, find that authorizing the City Manager to issue change orders for the additional Services to be provided by the Contractor is in the best interests of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue a change order to the existing agreement between the City of North Miami and BLDM USA, LLC., for additional services for the Wastewater Pump Station "A" Rehabilitation Project, pursuant to ***Invitation for Bid No. 55-20-21 – Rehabilitation of Pump Station No. "A";*** in an amount not to exceed Three Hundred Eight Thousand Three Hundred Eighty-Four Dollars and Forty-One Cents (\$308,384.41).

Section 2. **Effective Date.** This Resolution shall be effective upon adoption.
