

RESOLUTION NO. 2023-R-80

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RE-APPOINTING EMMANUELLA FLEURIMONT TO THE NORTH MIAMI COMMISSION FOR WOMEN, TERM ENDING ON NOVEMBER 19, 2024, IN ACCORDANCE WITH CHAPTER 2, ARTICLE III, DIVISION 13, SECTION 2-269, OF THE CITY OF NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the purpose of the North Miami Commission for Women is to serve in an advisory capacity by making studies, reports, and recommendations to the city council and to the city manager with respect to all matters pertaining to the status of all women in the city; and

**WHEREAS**, Chapter 2, Article III, Division 13, Section 2-269, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint one (1) member to the Commission and two (2) members shall be appointed by the mayor and council at-large; and

**WHEREAS**, members of the commission shall be permanent residents or employed in businesses in the city for two (2) or more years and shall have demonstrated a commitment to improving the condition of women through community and other service, in accordance with Section 2-269 of the City Code; and

**WHEREAS**, Councilman Pierre Frantz Charles desires to re-appoint Emmanuella Fleurimont to the North Miami Commission for Women.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**      **Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.


**Section 2.**      **Appointments.** The Mayor and City Council of the City of North Miami, Florida, hereby re-appoint Emmanuella Fleurimont to the North Miami Commission for Women.

**Section 3.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
