

**RESOLUTION NO. 2023-R-100**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND CALVIN, GIORDANO & ASSOCIATES, INC., TO INCLUDE ADDITIONAL SERVICES FOR THE UPDATE OF THE LAND DEVELOPMENT REGULATIONS AS REQUIRED FOR THE IMPLEMENTATION OF THE COMPREHENSIVE PLAN AMENDMENTS, AT AN ADDITIONAL COST NOT TO EXCEED ONE HUNDRED THIRTY-NINE THOUSAND EIGHT HUNDRED DOLLARS (\$139,800.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, On April 26, 2022, the City of North Miami (“City”) entered into an agreement with Calvin, Giordano & Associates, Inc. (“CGA”) for professional consulting services to assist staff with the statutorily required updates to the City’s comprehensive plan; and

**WHEREAS**, consistent with the adoption of the updated Future City 2045 Comprehensive Plan, the City is required to update its Land Development Regulations (“LDRs”) to implement the comprehensive plan amendments; and

**WHEREAS**, services will include the coordination with City staff to align the City’s LDRs with the comprehensive plan amendments at a cost not exceeding One Hundred Thirty-Nine Thousand Eight Hundred Dollars (\$139,800.00); and

**WHEREAS**, the City Administration respectfully requests that the Mayor and City Council authorize an amendment to the Agreement to attain additional services, for the aforementioned reasons, benefitting the City.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an amendment to the agreement between the City of North Miami and Calvin, Giordano & Associates, Inc., to include additional services for the update of the Land

Development Regulations, at a cost not-to-exceed One Hundred Thirty-Nine Thousand Eight Hundred Dollars (\$139,800.00).

**Section 2.     Effective Date.** This Resolution shall become effective immediately upon adoption.
